

EXECUTIVE SUMMARY

Introduction of Macadamia

- Macadamia nuts are regarded as world's costliest dry-fruit nuts and one of the world's best eating nuts.
- The plant is native of the sub-tropical forests (Queensland) Australia, and produces nuts with a white, creamy, highly valued kernel.
- Macadamia nuts are superior in flavor than other dessert nuts and posses a higher aroma and finer, smoother flavor than the hazel nut, which it most closely resembles. The raw kernel though edible, is usually consumed after roasting.
- The kernels are a good source of vitamin B, calcium, phosphorus, and iron. They have the highest amount of beneficial monounsaturated fats of any known nut
- They also contain approximately 22% of omega-7 palmitoleic acid, which has biological effects similar to saturated fat.





South Africa is the world's largest commercial producer accounting for roughly 40% (i.e. approximately 77,000 metric tonnes of nuts in shell) per year produced globally.

India has considerable potentiality for commercial cultivation of this crop in many areas of tropical and subtropical regions with the suitable variety called Beaumont which has 100 years of tree life.



Climate, Soil & Varieties:

Macadamia **trees thrive in warm temperate** to tropical climates, ideally at altitudes up to 1,500 meters above sea level, and require minimal rainfall. They can be successfully cultivated in areas where other tropical fruits, such as mango, papaya, banana, and avocado grow well, typically yielding satisfactory results similar to Australia in suitable Indian regions. the species grow as small to large evergreen trees, **2 to 12 meters tall.**

They particularly benefit from fertile volcanic soils and alluvial areas near rivers and creeks, rich in humus, providing optimal conditions for growth.

In India, the suitable Macadamia species are **Tetraphylla** and **Integrifolia**, known for their excellent taste and high oil content, with **Beaumont** being the most **commercially successful** subvariety recommended for largescale estates worldwide. Beaumont trees are distinguished by their dense, deep green foliage and fragrant pink flowers in spring, contributing to a high yield of delicious nuts.

These trees flourish in deep, welldrained loams and sandy loam soils

with a pH range of 5.5 to 6.6, often in agro-climatic conditions similar to coffee cultivation.

Grafted sapling trees begin producing approximately **3-6 kg of nuts** per tree per year by the 3rd to 4th year, increasing to **90-110 kg per tree per year by the 15th year**, with a productive lifespan of 80-85 years; additionally, Beaumont nuts have shells that are easier to open, stack, and pack compared to other varieties.

Life Cycle of Macadamia Nut



Crop Process of Macadamia Nut



Macadamia Tree Growth at a Glance



Style-2 & 3: These are blends of whole and half kernels in various ratios that can be customized to suit a particular application or price point. **Style-4:** These are smaller half kernels and large pieces. Also used in a wide range of snacks and ingredient applications, as an ingredient in confectionery, cookies, cereals, and cooking. **Style-5 to 7:** These are kernel pieces with Style 5 larger pieces and Style 7 smaller pieces. These styles are mostly used as an ingredient in almost any application, including ice cream, baked products, confectionery, cereals, health bars, salads, and other serving food.



At, **NURSERIES WING**, we develop grafted varieties of Macadamia Saplings and grow the same upto 2 years after germination of the seeds. After that, the 2 years old Grafted Macadamia Plants will be planted in our Estates; and also, we sell in the open market for our Contract Farming farmers who associated with us.



At, ESTATES WING, we develop Macadamia Estates at suitable areas in the states of Telangana, Andhra Pradesh and Karnataka. The estate lands will be well developed with Macadamia Plantation, Drip Irrigation System, Electricity, Roads, Boundary wall/Fencing, Arch, Security, Quarters, Lab, Store, Bore-wells, Motors, Machinery, Agricultural Tools and Tackles etc. After complete development of the Estates we sell the developed estate lands to enthusiastic investors and we maintain the same on behalf of them with our own cost on revenue sharing basis.



At, CONTRACT FARMING WING, we supply highly matured and qualitative Macadamia plants to all of the Horticulture farmers who are interested in the farming of Macadamia on buy-back basis. Not only supply of the plants but also support technically in regular growing practice of the Macadamia at their farm field through our Agronomists for the better yielding. After that, we buy the Macadamias from them at their farmgate as per the price given by us at the time of buy-back agreement. At, **MANUFACTURING WING**, we collect Macadamia Nuts from our Estates and also from our Contract Farming wing; and we process the same in our own Macadamias Process Plant, right from de-husking, removal of hard wood shell, collecting the Macadamia Kernels, size sorting and roasting; exporting it to global markets in bulk and also we supply Macadamias in consumer packaging size from 100-500 grams on our own brand which will be available online and offline markets in India. We also pack and supply Macadamias on third-party brands who are multi-national FMCG companies on regular basis.


